HE PULLED THE RIGHT SIDE CENTER OF THE TRAILER IN TO A CONCRETE GUARD PULLING THE LOADING HEADS OUT OF THE BRACKETS AND TEARING A HOLE IN THE BELLY LINES.THIS CAUSED THE FUEL IN THE LINES TO RUN OUT ON THE DRIVE.ONE OF THE BELLEY VALVES WAS DAMAGED AND CAUSED THE LOSS OF PRODUCT FROM THAT COMPARTMENT.THE LEAK WAS STOPPED BY STORE PERSONNEL AND DRIVER, THE SPILL WAS CONTAINED TO DRIVE.
