Mechanical Associate, reported product was released to the ground, to the cement and drip pans when they over filled Tankcar NATX 81019 in the fueling facility at the North Railroad in Denver, CO. Manager of Environmental Field Operations, was notified and placed in a conference in with the Mechanical Associate who stated he placed absorbent pads down for surface remediation and the soil would be dug up during daylight hours of 06/15/2007. State and federal notifications were issued. At 01:58 PM, Manager of Environmental Field Operations, advised the ground was inspected and there was no digging or any other remediation required.
