DURING SWITCHING OPERATIONS, YARD JOB SHOVED TRACK WITH POINT CAR (TANK CAR) COLLIDING WITH A LOADED COIL STEEL GONDOLA THAT WAS ROLLING FREELY ON LEAD TRACK THAT WAS SWITCHED BY ANOTHER YARD JOB. COLLISION RESULTED IN APPROX 6 INCH SLASH TO A-END TANK HEAD APPROX 2 FEET UP FROM BOTTOM HEAD SEAM, ALLOWING PRODUCT TO SPILL FROM PUNCTURE. REMAINING PRODUCT WAS TRANSLOADED TO TANKER TRUCKS. OVER 40% OF SPILLED PRODUCT ON GROUND WAS INITIALLY RECOVERED, WITH THE REMAINING SPILLED PRODUCT ON GROUND FLUSHED & NEUTRALIZED. CAUSE OF THIS INCIDENT WAS FAILURE TO PROTECT SHOVING MOVEMENT DUE TO ABSENCE OF MAN ON OR AT THE LEADING END OF MOVEMENT. BNSF HAS REEMPHASIZED THE IMPORTANCE OF PROTECTING MOVEMENTS IN A CURRENT BROADCAST OF SAFETY BRIEFING TOPICS ISSUED TO ALL EMPLOYEES ON JULY 18, 2000.
