UNIVAR WAS DELIVERING IBC'S OF SODIUM HYDROXIDE TO BALL METAL. FORKLIFT OPERATOR REMOVED 2 IBC'S AND RE-ENTERED THE VAN TRAILER TO PICKUP THE THIRD. WHEN HE PICKED THE TANK UP, HE NOTICED LIQUID COMING FROM THE OUTLET VALVE. HE PUT THE TANK BACK DOWN AND EXITED THE TRAILER. THE VALVE HAD BROKEN OFF THE TANK AT THE PIPE STEM THAT CONNECTS THE VALVE TO THE TANK. ALL OF THE SPILLAGE WAS CONTAINED ON THE CONCRETE DOCK APRON AND POOLED AT A PROTECTED STORM DRAIN.
