Describe:

A tank car was overloaded, but did not spill out. While attempting to off load the excess product, it was discovered the internal valve for the bottom outlet was frozen. Steam was applied to the bottom outlet in order to open the frozen valve. While steaming the valve, the rupture disk ruptured causing product spillage. Approximately 130 gallons of product were released. A vacuum truck and response team was brought in to recover the spilled product and wash the equipment sprayed by the product. All free product and rinse water was collected for proper disposal at an approved TSD Facility. Citric acid was spread on the ground to neutralize the pH.
