THE CONTENTS OF THE TRAILER BROKE THROUGH THE ROOF AND WERE LAYING ON THE GROUND. ONE DRUM OF SODIUM HYDROXIDE WAS PUNCTURED. ONE DRUM OF SULFURIC BROKE AND THREE DRUMS OF HYDROCHLORIC WERE LEAKING.
