TWO VEHICLES WERE INVOLVED IN THE SEQUENCE OF EVENTS THAT LED TO THIS INCIDENT. BOTH VEHICLES WERE EAST BOUND ON I-40, IT WAS MISTING RAIN MIXED WITH SLEET, TEMPERATURE AROUND 32 DEGREES. BRIDGES AND OVERPASSES WERE JUST BEGINNING TO ICE OVER. A MALONE & HYDE REFRIGERATED BOX VAN WAS IN FRONT OF THE WOOTEN TRANSPORT TRACTOR/TANKER APPROXIMATELY 300 FEET WHEN THE MALONE & HYDE LOST CONTROL AND WENT INTO A JACKKNIFE CROSSWISE OF THE ROADWAY. WOOTEN UNIT TRYING TO AVOID THIS INCIDENT ALSO WENT INTO A JACKKNIFE WHICH RESULTED IN THE FORWARD END OF THE TANKER STRIKING THE REAR OF THE VAN CAUSING THE TANKER TO RUPTURE AND SPILLING APPROXIMATELY 2132 GALLONS OF JET FUEL. SEE ATTACHED PAGE FOR PERSONNEL WHO INVESTIGATED AND MADE REPORTS AT THE SCENE.
