EAGLE TRANSPORT WAS CONTRACTED BY CLEVELAND INDUSTRIES TO HELP WITH A LINE FLUSH PROJECT AT DOUGLAS INTERNATIONAL AIRPORT IN CHARLOTTE, NC. WE WOULD PROVIDE FOR EQUIPMENT AND MANPOWER. BEFORE THE JOB BEGAN WE DISCUSSED THE JOB WITH CLEVELAND INDUSTRIES, WE SHOWED OUR HOSES AND EXPLAINED TO THEM THAT THESE WERE NON-PRESSURE, GRAVITY DROP HOSES, THEN OUT TERMINAL MANAGER ASKED HOW MUCH PRSSURE AND BACK PRESSURE WOULD BE USED AND THEY TOLD HIM THAT THE PRESSURES BEING USED WOULD NOT EXCEED 10 PSI. WE STARTED THE JOB AND OUR HOSES AND THE HOSES COULD NOT TAKE THE PRESSURE, RESULTING IN A SPILL. WE CHECKED THE PSI AND AT THE TIME OF THE SPILL THE PRESSURE WAS 65 OR 75 LBS. THIS SPILL IS STILL UNDER INVESTIGATION, WE BELIEVE THAT THE SPILL COULD HAVE BEEN PREVENTED IF CLEVELAND INDUSTRIES HAD NOT USED OUR EQUIPMENT IMPROPERLY. TOO MUCH PRESSURE. THE AIRPORT CONTROLLED THE PUMPS. THE SITE WAS CLEANED AND WORK RESUMED WITH STEEL PIPE BEING USED INSTEAD OF OUR HOSES. THIS IS CLASSIFIED AS A NON-PREVENTABLE SPILL.
