VEHICLE #1 WAS TRAVELING SOUTH ON TANNER MILL ROAD. VEHICLE #1 TRAVELED ONTO THE WEST SHOULDER OF THE ROADWAY. THE DRIVER LOST CONTROL. VEHICLE #1 ROTATED COUNTER CLOCKWISE AS IT RE-ENTERED THE ROADWAY. VEHICLE #1 OVERTURNED, TRAVELED OFF THE EAST SHOULDER OF THE ROADWAY, STRUCK AN EMBANKMENT AND CAME TO REST. VEHICLE #1 CAME TO REST FACING EAST ON THE DRIVERS SIDE OFF THE EAST SHOULDER OF TANNER MILL ROAD. THE DRIVER OF VEHICLE #1 STATED THAT HE HAD STRUCK A LOW HANGING UTILITY LINE WHICH CAUSED HIM TO LOSE CONTROL PRIOR TO TRAVELING ONTO THE SHOULDER OF THE ROADWAY.
