Under Quality Distribution Claim 22580, a Quality Distribution tanker was involved in a motor vehicle accident, leaving the roadway and ending up on its passenger-side. The contents of the cargo tank were transloaded to a second tanker and the vehicle was uprighted. An environmental response company then excavated the diesel impacted soil and containerized it for proper transportation and disposal. The excavated area was then backfilled, regraded and restored to pre-spill conditions.
