THE DRIVER WAS SPRAYED WITH ACID ON HIS FACE, ARM AND BACK THE DRIVER RECEIVED FIRST AND SECOND DEGREE BURNS. THE DRIVER WAS TAKEN TO THE HOSPITAL. TREATED AND RELEASED TO HIS HOME. THE REMAINS OFF AT THIS TIME AND CONTINUES TO RECEIVE MEDICAL TREATMENT THE DRIVER HAD HOOKED UP AND HAD TAKEN HIS PPE JACKET OFF AND HIS GLOVES AND HARDHAT. THERE BY LEAVING HIM EXPOSED-THE HOSE WAS WORNED THAT CAUSED IT TO RUPTURE. A FULL ROOT CAUSE ANALYSIS HAS BEE MADE.
