Driver Froze for a minute or longer and then reacted by shutting the flow at the tanker then shut off the truck PTO. The spill was in a cement containment area and everything was pushed into a secondary containment area. UPT driver and shop staff pumped up diesel and water back into the tanker and 3rd party vendor(Crystal Clear) hired by Vulcan Material pumped up the rest.
