VEHICLE WENT OUT OF CONTROL ON LIGHTLY ICED ROAD. VEHICLE OVERTURNED ON ROADWAY, FILL TUBE ON RIGHT HAND SIDE OF TANK WAS BENT AND CRACKED CAUSING EXCESS FLOW VALVE TO DEFORM AND MALFUNCTION. LIQUID SPEWED UNTIL VALVES WERE SHUT OFF AND FILL TUBE WAS STRAIGHTENED ALLOWING EXCESS FLOW VALVE TO OPERATE AND SHUT OFF FLOW. TRUCK WAS RIGHTED AND MOVED OFF ROADWAY. CARGO TANK WAS THEN PUMPED OUT. VEHICLE WAS TOWED TO REPAIR SHOP. ALL LIQUID RELEASED WAS EVAPORATED AND NO CLEANUP WAS NECESSARY.
