Driver of the cargo tank truck attempted to turn around in the drive of a closed business. When pulling back into the roadway driver allowed the left side trailer wheels to enter the roadway drainage ditch. This caused the trailer to lean to the left to a position of almost turning over. Tow trucks were brought in to stabilize the trailer. The material was transferred to another trailer. There was no loss of product. Roadway was closed as a precaution.

In this report I had to indicate a 1 gallon spill to force the report to enter. The system would not accept "0". This needs to be corrected in this reporting system. "0" should be an amount. NO MATERIAL WAS LOST.
