CN south bound train M33471-30 derailed ten (10) cars of which one(1) of the cars was regulated commodity. The derailment occurred on the Yazoo Sub at milepost 104.0, Phillip, MS. All appropriate departments notified. One (1) tank car containing Dicyclopentadiene was punctured by a coupler and leaked. Product was contained to the site. All remaining product in the tank car was transferred. Spilled material was remediated by Environmental Department.
