A FLATBED TRUCK WITH A CARGO TANK PULLED AWAY FROM A LOADOUT WITH THE HOSE STILL ATTACHED TO THE LOADOUT VALVE. THE HOSE PULLED THE VALVE ON THE STORAGE TANK OUT SPILLING PRODUCT INTO SECONDARY CONTAINMENT. THE TRUCK TANK WAS NOT DAMAGED, NOR WAS THE HOSE. THE PRODUCT WAS CONTAINED INSIDE THE CEMENT CONTAINMENT AND WAS RECOVERED AND USED AGRONOMICALLY. THE RINSATE GENERATED TO CLEAN THE CONTAINMENT AREA WAS LIKE WISE USED AGRONOMICALLY. A CITY EMPLOYEE CLAIMED TO HAVE INHALED SOME VAPOR AND WAS TREATED AT A LOCAL CLINIC.
