OUR DRIVER WAS TRAVELING EAST ON I-74 AT THE 17 MILE MARKER WHEN HE FELL ASLEEP. (WE BELIEVE) HE WENT GRADUALLY OFF THE ROAD & BURM & THEN NOTICED OR AWOKEN. HE JERKED THE WHEEL BACK TO THE LEFT CAUSING THE VEHICLE TO BECOME UNBALANCED AND THE FORWARD MOTION OF THE LOAD TURNED THE VEHICLE ON ITS RIGHT SIDE WHERE IT SLID FOR 280 FT. RUBBING THE SIDES AGAINST THE ROADWAY UNTIL HOLES WERE WORN IN THE SIDES OF ALL 4 COMPARTMENTS. FINALLY COMING TO A REST WITH FIST SIZE HOLES IN ALL 4 COMPARTMENTS. WE ESTIMATE IT TOOK 15 MINUTES OR LESS TO EMPTY OUT ALL THE LOAD EXCEPT 200 GALLONS IN COMPARTMENT #4. 7600 OF THE 7800 GALLONS OF DENATURED ETHANOL WENT IMMEDIATELY INTO THE DITCH FROM THE HOLES IN EACH COMPARTMENT. SPARKS (IF ANY) DID NOT IGNITE THE ALCOHOL. OURS WAS THE ONLY VEHICLE INVOLVED. TRACTOR & TRANSPORT TRAILER AND 7600 GALLONS OF ETHANOL WERE A TOTAL LOSS TO CARRIER DRIVER WAS NOT HARMED AT ALL. HE WAS FIRED FOR FAILURE TO KEEP CONTROL OF HIS VEHICLE. PAVEMENT WAS DRY AND OUR VEHICLE WAS IN PROPER CONDITION. DRIVER HOURS OF SERVICE WAS NOT THE PROBLEM EITHER. HE WENT ON DUTY AT 6:30 PM ON 9-22-94 & THE ACCIDENT HAPPENED AT 1:00 AM ON 9-23-94. HE HAD HIS PROPER BREAK FROM 6:30 AM 9-22-94 TO 6:30 PM 9-22-94. (CLEANUP)
