On November 5, 2014, an Empire Express, Inc. tractor trailer was involved in a multiple vehicle accident on I-40, Mile-marker 276 in West Memphis, AR. The accident resulted in a trailer fire. As a result of the fire, multiple containers of hazardous cargo were totally damaged and lost, including UN3082 Environmentally Hazardous Substance N.O.S. Liquid Acrylates. B&P Enterprises responded out of South Haven, MS to respond and clean the release. There was no salvageable freight identified once B&P arrived on-site. All contaminated materials & debris were recouped and taken for disposal. The site was restored to its previous condition.
