THE TOTE WAS LOADED ON THE REAR OF THE TRAILER AT OUR HURON DOCK AND THE DRIVER CLOSE THE DOOR AND WAS GOING TO ALPENA SOUTH DAKOTA AS HE WAS TURNING THE CORNER ONTO HWY 37 THE TRLR. REAR TIRES WENT UP ONTO THE CURB AND THIS CAUSE THE TRAILER TO TWIST AND THE DOOR CAME UNLATCHED AND OPEN AND THE BUMP CAUSE THE SOLUTION TO SPLASH FORWARD AND ALONG WITH THE MOMENTUM OF THE TRUCK WHEN IS SPLASHED BACK IT SLID OUT THE BACK DOOR, FALLING ONTO THE HIGHWAY AND SPLITTING OPEN SPILLING THE CONTENTS. IMMEDIATELY THE DRIVER CALLED (911) AND EMERGENCY VEHICLES ARRIVED -FIVE- POLICE-HIGHWAY PATROL-CITY-CARRIER ENFORCEMENT-EMERGENCY MANAGEMENT. THE DRIVER WAS GIVEN A WARNING FOR NOT HAVING THE LOAD PROPERLY SECURED IN THE TRAILER AND WAS WARNED ABOUT CHECKING TO SEE IF THE DOOR WAS PROPERLY LATCHED.
