TANK CAR PLMX 3964 CONTAINING ANHYDROUS AMMONIA WAS DELIVERED TO CSSB AT SOUTH BEND, IN, ON APRIL 2, 1990 BY CONRAIL WITHOUT DOCUMENTATION. CSSB CREW DID NOT PULL ON APRIL 3, 1990 ACCOUNT NO DOCUMENT. AT APPROX 6:57 PM, APRIL 4, 1990 REPORT RECEIVED THAT PLMX 3964 WAS LEAKING FROM TOP DOME. INVESTIGATION REVEALED THAT CAR WAS LEAKING FROM TOP DOME. SOUTH BEND FIRE DEPT HAZMAT TEAM ATTEMPTED TO SECURE LEAK TO NO AVAIL. CIL HAZ MAT TEAM ARRIVED SOUTH BEND AT 9:25 AM 4/5/90 AND SECURED THE LEAK WHICH WAS DUE TO LOOSE AND MISSING BOLTS. (IT IS BELIEVED THAT UNKNOWN PERSON REMOVED ONE BOLT AND LOOSENED OTHERS.
