THEREFORE WHEN ATTEMPTING TO UNLOAD, THE DRIVER REMOVED THE DUST CAP AND SULFUR SPILLED ON THE DRIVER AND THE GROUND. THE DRIVER DID MANAGE TO CLOSE THE VALVE AND THUS AVOID SPILLING THE WHOLE LOAD. THE DRIVER WAS TAKEN TO THE HOSPITAL AND THE SULFUR WAS CLEANED UP.
