INVESTIGATION FOUND VAPOR COMING FROM VALVE THREADS ON TOP OF CAR. FIRE DEPT. APPLIED WATER TO VAPOR AND EVACUATED IMMEDIATE AREA. CONSIGNEE REP TIGHTENED VALVE AND WHEN SHIPPER RESPONSE TEAM ARRIVED VALVES WERE TESTED AND CAR WAS OK TO RETURN TO SHIPPER FOR REPAIRS. EVACUATION WAS A PRECAUTIONARY MEASURE ONLY LASTING ABOUT 4 HRS. THERE WERE NO INJURIES.
