Describe:

VEHICLE WAS WESTBOUND ON US HIGHWAY 26 WEST OF RIVERTON, WYOMING. BETWEEN MM 69 & MM 70 THE REAR AXLE BRAKES ON THE PUP TRAILER LOCKED UP. THE PUP STARTED SKIDDING TO THE LEFT UNTIL IT ROLLED OVER AND INTO THE REAR FRAME OF THE FRONT TRAILER, GOUGING A HOLE IN THE FRONT OF THE PUP TRAILER, SPILLING PRODUCT ONTO THE HIGHWAY. THE UNIT CONTINUED FORWARD WITH THE PAVEMENT GRINDING ON THE LEFT REAR OF THE PUP TRAILER. WHEN THE UNIT CAME TO A STOP THE LEFT SIDE HAD A SMALL HOLE GROUND INTO IT BY THE PAVEMENT, CAUSING THE BALANCE OF PRODUCT ON THE PUP TO LEAK OUT. THE CONCLUSION REACHED FROM THE EVIDENCE WAS THAT THE DRIVER PROBABLY DOZED OFF AND WHEN HE CROSSED THE BRIDGE, THE BUMP WOKE HIM UP. HE SAW THE CURVE IN THE ROAD AND THE RED ROCK WALL AHEAD OF HIM AND HE TURNED TO THE RIGHT AND HIT HIS BRAKES CAUSING THE ACCIDENT. THE JET FUEL RAN OFF THE PAVEMENT AND ONTO THE DIRT AT THE EDGE OF THE ROAD. A SMALL AMOUNT (LESS THAN 500 GALLONS) RAN INTO THE WIND RIVER. ABSORBENT BOOMS WERE PLACED DOWNSTREAM TO CATCH ANY PRODUCT. THE SOIL WAS EXCAVATED AND CLEAN SOIL PUT BACK.
