UPON IMPACT THE PALLET JACK WAS SLAMMED INTO THE IBC AND PUNCTURED IT APPROXIMATELY 12-14" FROM THE BOTTOM WHICH CAUSED A LEAK. THE PUNCTURE WAS A SPLIT. ATTACHED IS THE REPOSNSE REPORT FROM SOONER EMERGENCY SERVICE, THE COMPANY WE CONTACTED TO ACCESS AND CLEAN UP THE SPILL.
