Describe:

Liquid was reported to be leaking from the B-end of the car and a vapor cloud was visible. Inspection of the car revealed the tank cars liner had failed. Temporary containment was placed under the car while waiting for transfer equipment and portable tanks to arrive on site for transfer of product. On arrival of equipment, product was transferred to portable tanks. Upon completion of the transfer, the car was moved to an isolation track. Product from the portable tanks was transferred into tank trucks, transported to consignee and off loaded. The impacted area was remediated by flushing with a water/soda ash solution to neutralize the acid. Temporary repairs will be made to the car to prevent release of any residual product while moving back to shop for repairs once an OTMA has been submitted by the shipper and approved by the FRA.
