May 5, 2019 at 0635 ET A Trimac tractor trailer experienced a single vehicle accident resulting in a loss of cargo on I-20 in Stanton, TX. It was reported that an unknown amount of Red Dye Diesel released impacting the roadway and soil shoulder. The extent of the release was unknown at the initial time. Trimac dispatched a relief tank to the site. ERTS spoke with the driver who reported the unit slid causing 3 or 4 welds to crack. The tank was carrying ~7700 gallons. ERTS has dispatched Talon LPE to respond and perform containment and cleanup activities. Talon LPE arrived onsite and assessed the release. They estimated the release to have been 5000 gallon of diesel fuel which impacted the road way, soil shoulder and 100 ft of a ditch line which leads to a drain. Talon LPE confirmed the material impacted the drain. A vacuum truck was used to recover the lost material in the drain while a skid steer was used on the roadway and soil to recover the majority of the material. The site was secured for further remediation.
