ON JANUARY 15, 1990, AT ABOUT 3:30 AM, SOO LINE RAILROAD TRAIN NO. 503, WHILE BEING HANDLED BY THE CSX RAILROAD BETWEEN DETROIT AND CHICAGO, WAS STOPPED AT MICHIGAN CITY, INDIANA DUE TO FIRE BEING DISCOVERED IN CONTAINER CASU 705265, ON RAILCAR CP 521184. THE CONTAINER CONTAINED 70 55 GALLON DRUMS OF POTASSIUM PERMANGANATE. THE LOCAL AUTHORITIES EVACUATED AN APPROXIMATE FOUR-SQUARE BLOCK RESIDENTIAL AREA AND SOME 100 FAMILIES (175 PEOPLE) WERE DISPLACED FROM THEIR HOMES FOR APPROXIMATELY 20 HOURS. OUR INVESTIGATION HAS DEVELOPED THE FIRE ORIGINATED FROM WITHIN THE CONTAINER, WHICH WOULD INDICATE THE PRODUCT WAS EXPOSED DUE TO LOAD SHIFT AS A RESULT OF IMPROPER OR INADEQUATE BLOCKING AND BRACING.
