THE DRIVER LOST CONTROL OF VEHICLE WHILE AVOIDING A ANIMAL IN THE ROADWAY, THUS CAUSING THE TRUCK AND TANKER TO HIT A GUARD RAIL. THIS CAUSED THE TANKER TO ROLL OVER ONTO ITS LEFT SIDE WHILE HITTING THE GUARD RAIL AND SPLITTING THE TOP LEFT SIDE OF THE TANKER OPEN. ALL THE PROPER AGENCIES WERE NOTIFIED, AND A HAZARDOUS CLEAN UP CREW WAS BOUGHT OUT TO CLEAN UP THE SITE. THE SITE WAS CLEANED AND THE HIGHWAY WAS REOPENED.
