GBRX 711513 was found leaking material from the bottom of the jacket on the A-end around the bolster and stub sill. The car was setout and a containment was placed under the leak point. The contents of the car was transloaded into a lined frac tank to the stop the leak. After cleaning and purging the car, the car was inspected by the response contractor and a corrosion hole was found on the A-end just past the weld of the A-end head and the first tank shell ring. The liner was found to be corroded around the hole and at other points in the area of the hole.
