Describe:

At approximately 1345 MT on 8/18/2015 a Clean Harbors Environmental services Inc. power unit and semi roll off trailer carrying one 30 yard intermodal container was travelling southbound on Colorado state highway 71. At approximate mile marker 183.5 the vehicle's right front steer tire left the roadway and entered the soft shoulder causing the power unit and semi trailer to lose control and overturn onto the vehicle's right side. The loss of control and subsequent rollover collision caused the semi trailer's intermodal container to become unsecured. The intermodal container's contents were released as a result of the vehicle rollover accident. An emergency response team was summoned, donned the proper personal protective equipment, and remediated the release. The released material was reloaded and transported to the intended disposal facility. NRC report #21966. Colorado Dept of Public Health & Environment operator Anne Nedrow provided report #2015-0537.
