DRIVER WAS TRAVELING ON NARROW BLACKTOP ROAD IN 2010 FREIGHT LINER BOBTAIL WHEN HE GLANCED AWAY FROM THE ROAD BRIEFLY. TRUCK WENT ONTO MIDDLE SHOULDER OF ROAD, INTO THE DITCH, AND THEN OVERTURNED ONTO ITS SIDE. DRIVER COULDN'T GET TRUCK ENGINE TO SHUT DOWN AND EVENTUALLY IGNITED EITHER FUEL OR PROPANE & FIRE ENSUED. DRIVER WAS ABLE TO GET AWAY FROM TRUCK TO SAFETY. EVENTUALLY PRESSURE INCREASED IN CARGO TANK UNTIL REAR HEAD SHELL SPLIT OPEN RELEASING LARGE QUANTITY OF PROPANE. PROPANE IN TANK CONTINUED TO POUR FOR APPROXIMATELY 3 HOURS. INITIAL ACTIONS TO MITIGATE INCIDENT WERE TO EVACUATE FROM HOUSE APPROXIMATELY ½ MILE AWAY.
