P-1 WAS DRIVING V-1 E/B ON SR-58, WHEN HE SAW A VEHICLE BEHIND HIM FLASHING ITS LIGHTS. P-1 NOTICED SMOKE COMING FROM V-1'S TRAILER. P-1 PULLED OVER TO THE RIGHT SIDE DIRT SHOULDER JUST EAST OF LENWOOD ROAD. P-1 DETERMINED THAT HIS TRAILER CONTENTS WAS ON FIRE AND THAT HE WOULD NOT BE ABLE TO PUT THE FIRE OUT. P-1 UN-HOOKED THE TRACTOR FROM THE TRAILER AND MOVED IT TO A SAFE LOCATION. V-1 WAS NOT PLACARDED AND DUE TO FIRE DAMAGE IT IS UNKNOWN IF THE PRODUCTS WERE LABELED. P-1 HAD THE SHIPPING PAPERS. THE PACKAGING WAS CARD BOARD BOXES. THE CLEAN UP WAS DONE BY CALPI OUT OF BAKERFIELD CALIFORNIA. THE MATERIAL WAS ABSORBED WITH A SAND LIKE PRODUCT, SCOOPED, AND HAULED AWAY.
