EMPLOYEE DISCOVERED RELEASE AT TRUCK TERMINAL AND IMMEDIATELY CLOSED VALVES TO STOP RELEASE. IT WAS DETERMINED THAT VALVES WERE ACCIDENTLY LEFT UPON DEPARTURE FROM SHIPPER TO TRUCK TERMINAL. THE RELEASED CHEMICAL IMPACTED THE TRUCKING TERMINAL PROPERTY, APPROXIMATELY 8 MILES OF ROADWAY AND THE PROPERTY AT A SCALE HOUSE. A CLEANUP CONTRACTOR WAS HIRED TO PROVIDE CLEANUP ACTIONS TO ALL PARTIES IMPACTED BY THE RELEASED SODIUM HYDROXIDE SOLUTION. PROPER PRE-TRIP INSPECTIONS WILL BE REVIEWED WITH ALL DRIVERS TO PREVENT FUTURE INCIDENTS.
