DRIVER OF A CARGO TANK FOLLOWED THE WHITE LINE ON THE HIGHWAY TO CLOSELY AND VEERED SLIGHTLY OFF ROAD. THIS CAUSED THE REAR TRAILER TO MOVE OFF CENTER AND TIP OVER THE TRUCK ITSELF AND FRONT TRAILER REMAINED IN TACT/UPRIGHT AND ON THE ROADWAY BUT THE REAR TRAILER WENT ON ITS SIDE. THE TRAILER LEAKED 1117 GALS. OF CLEAR DIESEL FUEL ONTO PART OF THE MANWAY AND SOIL ON THE SIDE OF THE LOAD. THE FUEL REMAINING WAS PUMPED OUT AND REAR TRAILER WAS LIFTED UPRIGHT AND DROVE AWAY. THE SOIL ON THE SIDE OF THE ROADWAY WAS IMMEDIATELY ESCAVATED AND STOCKPILED PENDING DISPOSAL. THERE HAVE BEEN NO HAZARDOUS WASTE MANIFESTS GENERATED YET. ONLY NRCRT WASTE DISPOSAL.
