Describe:

A private citizen reported to Norfolk Southern they observed vapors coming from tank car RCRX2303 near Ft Payne. AL. The train was stopped and inspected by Norfolk Southern personnel. Tank car RCRX was found to have product that leaked from the fill hole. Norfolk Southern dispatched HEPACO to the site to handle. Upon inspection, HEPACO found 2 of 3 fill hole bolts disengaged. HEPACO secured the fill hole and cleaned spilled product from the cars exterior.
