THE 1400 GALLON MC 307/312 VACUUM TANK TRUCK CONTAINED 1000 GALLONS OF SPENT SULFURIC ACID. UPON ARRIVAL AT THE PHOENIX TRANSFER FACILITY, THE DRIVER PREPARED TO UNLOAD INTO A STORAGE TANK. THE DRIVER PULLED THE "BLEEDER" VALVE TO REDUCE THE INTERNAL PRESSURE. UPON PULLING THE VALVE, LIQUID PRODUCT FLOWED FROM THE TANK THROUGH A CORRODED AREA ON THE BLEEDER LINE. THE VALVE WOULD NOT CLOSE, AND THE ACID WAS DISCHARGED ONTO THE GROUND. THE AREA WAS DIKED AND THE SPILLED MATERIAL VACUUMED INTO A STORAGE TANK. THE DIRT WHICH WAS CONTAMINATED WAS SOLIDIFIED AND TREATED. ALL OF THE ABOVE OCCURRED AT A PERMITTED HAZARDOUS WASTE FACILITY.
