On May 5, 2018 while shoving cars towards the hump in Moorman yard the coupling on an open gondola car (SOU65705) bypassed the coupler on SHPX206736. The bypassed coupler struck and dented the "B" End head of tank car SHPX206736. The dent caused the tank to tear away from the stub sill ripping a hole in the tank. Tank car SHPX206736 lost its entire load of alcohols, n.o.s. and ignited. The fire impinged on the jackets of 2 tank car containing butane causing heat damage to the jackets.(UTLX957745 & UTLX957730) The lading on these 2 cars were transferred to other tank cars.
