OUR UNIT WAS EASTBOUND ON I-OP AT APPROXIMATELY MILEPOST 85. DRIVER RASMUSSEN DROPPED AN ITEM OF THE FLOOR AND REACHED TO PICK IT UP, TAKING HIS EYES OFF THE ROAD. THE TRUCK ENTERED THE SOUTH DITCH AND OVERTURNED, AS DID THE LEAD TRAILER. THE FOLLOWING TRAILER (PUP) REMAINED UPRIGHT AND DID NOT SUFFER ANY LOSS OF CARGO. THERE WAS NO FAILURE OF EQUIPMENT, ONLY DRIVER ERROR. THE CARGO FROM THE LEAD TRAILER DISCHARGED UNTIL PRODUCT WAS BELOW THE LEVEL OF THE DOME, AT WHICH TIME FLOW CEASED. AFTER SOIL TESTING, THE CONTAMINATED MATERIAL WAS ACCEPTED BY THE RAPID CITY LANDFILL, FILL DIRT WAS HAULED IN, THE AREA LEVELED AND RESEEDING COMPLETED ALL REQUIRED CLEANUP OF INCIDENT SITE.
