Describe:

The driver had just finished loading a full load of diesel at Nustar in Stockton, CA on Navy drive deading to deliver load to Schneider, French Camp, CA when entering the southboud on ramp to Interstate 5. The driver was traveling too fast for the turn and the truck rolled over. The driver sustained no injuries and called the dispatch department. A witness called 911 and the California Highway Patrol was dispatched to the scene. Once the incident was reported to dispatch, the dispatch department called the environmental clean up company to contain any spill of product. Approximately 1263 gallons of diesel was spilled onto the highway.
