OUR 1992 DODGE PICKUP TRUCK AND THE ANHYDROUS AMMONIA NURSE TANK ENDED UP IN THE DITCH TURNING THE NURSE TANK OVER AND BREAKING OFF THE ANHYDROUS AMMONIA RELIEF VALVE AND CAGE. THUS RELEASING THE PRODUCT INTO THE AIR. EMERGENCY RESPONSE UNIT ARRIVED AT THE SCENE TO FOG DOWN THE ANHYDROUS AMMONIA RELEASE. PROPER AUTHORITIES HAVE BEEN CONTACTED AND CLEAN UP IS BEING DONE.
