OUR TRUCK WAS MAKING DELIVERIES, TRAVELING ON HWY 696 WEST. TOOK 35W SOUTH AND WAS TRAVELING SOUTH ON 35W TO HWY 280 EXIT. TOOK HWY 280 GOING SOUTH. ANOTHER VEHICLE CAUGHT THE ATTENTION OF OUR DRIVER. OUR DRIVER EXITED ON KASOTA AVENUE AND FOUND THAT PRODUCT WAS DRIPPING OUT OF TRAILER. OUR DRIVER CALLED THE OFFICE, WE IMMEDIATELY BROUGHT SEVERAL BAGS OF ABSORBANT OUT TO THE TRUCK AND AND ABSORBED ALL OF THE MATERIAL INTO THE ABSORBANT AND BROUGHT THE TRUCK BACK TO OUR WAREHOUSE WHERE WE CLEANED THE TRUCK. WE FOUND THAT THE VALVE HAD BROKEN ON A TOTE TANK AND CAUSED THE SPILLING OF ALL OF ITS PRODUCT, WHICH WAS LIQUID CAUSTIC POTASH 45%.
