THE DRIVER ARRIVED AT THE CONSIGNEE'S LOCATION, LACROSS INDUSTRIES, AND WAS TOLD BY THE RECEIVER THAT THE CONSIGNEE HAD THEIR OWN HOSE FOR THE TANK INTO WHICH THE PRODUCT WAS TO BE UNLOADED. THE DRIVER HOOKED THE END OF THE HOSE TO HIS PUMP, THE RECEIVER OPENED THE CONSIGNEE'S INBOUND LINE AND THE DRIVER STARTED HIS PUMP TO UNLOAD THE PRODUCT. AFTER PUMPING FOR APPROXIMATELY 10 MINUTES, THE CONSIGNEE TOLD THE DRIVER TO STOP PUMPING, THAT THERE WAS A SPILL. THE DRIVER SHUT DOWN HIS PUMP AND, AT THAT POINT, THE DRIVER AND THE RECEIVER CHECKED THE UNLOADING HOSE. THE CONSIGNEE'S UNLOADING HOSE WAS LAYING ACROSS THE ROOF OF A SHED WITH THE END OF THE HOSE OUT OF SIGHT. THE CONSIGNEE OPENED THE SHED AND THEY SAW THAT THE HOSE WAS LOOPED OVER THE SHED, NOT CONNECTED TO ANYTHING, AND HAD BEEN ALLOWING THE PRODUCT TO RUN DOWN THE STAIRS OF THE BUILDING INTO THE BASEMENT. EMERGENCY PROCEDURES WERE INSTITUTED, THE BUILDING WAS EVACUATED AND CLEAN UP STARTED.
