Describe:

On 10/5/2013, at 02:14 hrs., personnel in the CSXT Avon Yard Big Four discovered TILX110161, a loaded tank car of hydrochloric acid, leaking from a hole in the vapor space B-end just above the reporting marks. The car was isolated and the shipper, Bayer Material Science, and Hendricks Communication Center were notified. CHEMTREC Report #2013100500017. Summit, a CSXT emergency response contractor, was dispatched to the scene and found a penny size hole on the top of the B-end, about 5 feet from the catwalk before the lettering on the car. The issue was identified and corrective actions were communicated to the shipper, Bayer Material Science, Chad Blake, 412-777-7475. Contractor personnel patched the hole and transloaded the product from TILX110161 into tank car TILX111099. TILX110161 was decontaminated and placed on hold awaiting for a OTMA-1 for the car to be sent to Brewton, AL for repairs.

This incident did require a special switching move.
