Describe:

Driver was heading south when he went off the right side of the road and overcorrected. The gas truck overturned on the road before continuing off the left side of the road. There was a minor release of propane and motor fuel. The small propane release was coming from the hose damaged in the accident.

Describe:

The company has a rollover prevention policy titled, "SLIP OFF STAY OFF" with cab posters and training reminders. The idea is to bring the vehicle under control without attempting to radically change the path which can cause liquid load shifting and add to the potential for overturn. After each such accident a committee reviews the investigative facts to determine whether the driver followed company safety practices and whether disciplinary actions are appropriate. Our employees receive recurrent training for defensive driving, proper backing techniques and how to prevent rollovers. Employees must pass a driver recertification test every three years.
