Driver arrived at the consignee's and advised them that he had Ferric Chloride to deliver. Consignee's employee confirmed their tank had enough space to hold product & touched the fill line that he wanted the driver to connect to. Driver connected to the line that he was shown and then had the consignee's employee sign his paperwork stating he was hooked up to the proper connection. Consignee employee signed the paperwork and went inside the building. Driver proceeded to start the unloading process. A few minutes later the consignee employee came out of the building and told driver to shut down he was unloading into the wrong tank. The driver immediately stopped the delivery process, unhooked the hoses and moved the truck & trailer away from the building.
