OUR DRIVER WAS TRAVELING ON HIGHWAY 87 NORTHBOUND NEAR MILE POST MARKER 115 AT ELIZABETHTOWN, NEW YORK. VEHICLE FOR UNKNOWN REASON DRIFTED OFF EAST SIDE OF ROADWAY STRIKING APPROXIMATELY 200 FEET OF VINE GUARD RAIL BEFORE OVERTURNING INTO DITCH PUNCTURING THE FRONT FACE OF TANKER. AN EMERGENCY RESPONSE TEAM (OP-TECH) WERE CALLED ON THE SITE IN ORDER TO TAKE CHARGE OF THE SPILL OF HAZARDOUS MATERIALS. FIRST RESPONDERS ON THE SCENE NEEDED TO MAINTAIN A SAFE DISTANCE, AND WAITED THE EMERGENCY RESPONSE TEAM. THE ACCIDENT OCCURRED AT AROUND 2:09 AM. AND OUR COMPANY C.A.T. WERE NOTIFIED AT 8:00 AM APPROXIMATELY.
