THE VEHICLE THEN ROLLED ONTO ITS RIGHT SIDE. THE IMPACT WITH THE PILLARS TORE THE TANK VEHICLE OPEN AND THE CARGO ESCAPED INTO THE GROUND. OUR DRIVER WAS KILLED IN THE ACCIDENT. WE ENGAGED A CONTRACTOR TO CLEAN UP THE SPILL AREA AND RESTORE IT TO ITS PRE ACCIDENT CONDITION.
