Describe:

IT WAS RAINING ON THE NIGHT OF FEBRUARY 10, 1994 AND THE DRIVER PLANNED TO PULL INTO A PARKING LOT AT MIDNIGHT TO STOP FOR A BREAK. HE ASKED A FELLOW TRUCKER BEHIND HIM IF HE WAS CLEAR OF THE DITCH ON EITHER SIDE OF THE DRIVEWAY. IT WAS CONFIRMED THAT THE TRAILER WOULD MISS THE DITCH. HOWEVER, THE BACK RIGHT TIRES ON THE TRAILER WENT INTO THE DITCH AND THE DRIVER WAS THEN STUCK AND NOT ABLE TO PULL HIMSELF OUT. AT 0005 FEBRUARY 11, 1994 THE DRIVER CALLED THE LOCAL POLICE IN EUPORA, MS WHO IN TURN CALLED A TOW TRUCK OPERATOR. THE TOW TRUCK OPERATOR DECIDED TO PULL THE TRUCK AND TRAILER OUT OF THE DITCH BACKWARDS. THEY DID NOT HEAR THE WARNING THE DRIVER YELLED WHEN THE BOTTOM OF THE TRAILER CAUGHT THE CURB. THE BELLY VALVE WAS CRUSHED AND THE TRAILER BEGAN TO LEAK AT THE SEAMS. THE DRIVER AND TWO TRUCK OPERATOR TRIED TO CONTAIN THE LEAK AS BEST AS POSSIBLE WITH BUCKETS. THE M S DEQ WAS CALLED AND A REPRESENTATIVE WAS AT THE SCENE WITHIN HOURS. A CLEAN UP COMPANY IN THE AREA WAS CALLED AND WHEN THEY GOT TO THE SITE THEY TOOK OVER THE CLEAN UP PROCESS. THE TRAILER WAS REMOVED FROM THE DITCH AND EXTENSIVE CLEANUP CONTINUED AT THE SITE. THIS ACCIDENT MAY HAVE BEEN PREVENTED IF THE TOW TRUCK OPERATOR HAD NOT TRIED TO PULL THE TRUCK AND TRAILER OUT OF THE DITCH BACKWARDS. COPIES OF THE HAZARDOUS WASTE MANIFESTS ARE ATTACHED.
