Describe:

Employee pulled up and read the beginning percentage for tank. Employee then hooks up hoses to their line and then hooks onto the transport and then make sure all the lines are open and this is done visually.

Employee states that after he hooks up he fills out the delivery paperwork then waited for the tank to fill. After about 30 minutes the employee saw the line rupture. Employee stated that the line ruptured about 1 1/2 ' from where it goes into their tank. Employee turned off the truck engine, got out of the truck, and turned off all the valves on the truck and on their tanks and contacted the fire department and help from Ferrellgas Field members. The release lasted approximately 48 hours Ferrellgas representatives safely flared the tank until the tank was empty. The Fire department assisted by spraying the release site.
