A RANDOLPH'S INC. TRANSPORT DRIVER WAS UNLOADING DENATURED ALCOHOL INTO MOLO OIL COMPANY'S ABOVE-GROUND STORAGE TANK. HE THOUGHT THE LOAD WOULD FIT INTO THE TANK SO PROCEEDED, UNTIL FINISHED. THE TANK RAN OVER AND THE SPILL WASN'T DETECTED TILL LATER BECAUSE IT HAD SETTLED BELOW THE GRAVEL, WHICH SURFACED THE DIKED, CONTAINMENT AREA. AT THAT TIME, THE FIRE DEPARTMENT, DNR, AND HAZMAT CLEAN-UP COMPANY WERE NOTIFIED TO COME IN AND CONTROL THE SITUATION. THIS PARTICULAR DRIVER, HAS BEEN IN OUR EMPLOY FOR LESS THAN 60 DAYS AND WILL HAVE TO UNDER TAKE MORE INTENSIVE TRAINING IN THE FIELDS OF HAZMAT REGULATIONS AND COMPANY POLICIES INVOLVING UNLOADING PROCEDURES. ALSO, ALL OTHER EMPLOYEES WILL BE MADE AWARE OF THE INCIDENT AND THE POSSIBILITY OF DISQUALIFICATION FOR SUCH NEGLIGENCE.
